# IMPORTANT INFORMATION FOR APPLICANTS

### **ABOUT THE FUND**

The Brereton Memorial Fund was founded in memory of Philip and Gwen Brereton, of Rochdale, who died in December 2000.

Throughout their lives they gave up much of their free-time to work voluntarily for the Incorporated Association of Organists, the Royal College of Organists and the Oldham Rochdale and Tameside Organists' Association.

For many years Philip and Gwen were well-known as the Organisers of the IAO Annual Congress.

In particular they worked to help youngsters discover organ and choral music and were especially keen to encourage British organists to explore organ building and organ music throughout Europe and beyond.

# AIMS OF THE FUND

The Brereton Memorial Fund aims to support:

- A local memorial project to commemorate the work of Philip and Gwen Brereton
- Music education projects both in the North West area and nationally
- The teaching of the organ at every level to students of all ages.
- The nurturing of choral music especially church music

# HOW MUCH WE WILL FUND

The fund generally has in the region of £1000-£1500 per year to award to applicants, although this may vary from year to year.

- We will aim to offer at least two student bursaries per year to bona-fide organ students to attend the IAO annual Congress. (applications to be made directly to the Congress Organiser)
- We also hope to award a number of smaller grants per year.
- The trustees of the fund have agreed to consider the award of larger bursaries for far-reaching, more ambitious educational projects. Awards of this kind will

generally not represent more the 10% of the overall value of the Fund. [currently limited to £2900]

The following list of size of bursaries awarded in the past is intended as guidelines only:

- for help towards musical tuition costs £300
- towards the costs of attending a course £100
- towards the costs of purchasing music £100

In general a time limit of 18 months is expected in which you must claim your award (or 6 months in the case of music vouchers awarded). Time limits for projects are decided on a case by case basis.

### WHAT WE WILL NOT FUND

We will not undertake to fund on-going costs. We will not fund running costs for current activity.

#### **HOW TO APPLY TO THE FUND**

The trustees of the Brereton Memorial Fund welcome applications from individuals, charities or other societies/groups for projects which further the aims of the fund.

Please use the application form to make your application. Use a separate sheet to give us any further information you feel will help your application.

# You can apply for a grant from the Brereton Fund if:

A) you are a not-for profit group **and** 

You have a constitution or a set of rules and

You have a bank or building society account which requires at least two signatures and

You can enclose your most recent annual accounts or statement of income and expenditure. These must be audited or signed as approved by your Chair, or other senior office holder

#### OR

B) You are an individual:

wishing to take lessons on the organ or wishing to embark on a research project related to the organ

Applications should be made on the application form APPLICATIONS SHOULD BE SENT TO THE ADDRESS BELOW BY 31<sup>st</sup> January each year.
